- **9 installment payment option.**
One of your 9 installments payments was due October 1st.
- **4 installment payment option.**

Lilliput does Lifetouch's "Family Approval Program" it is designed to create the best experience for our families with a fast turnaround. All children are photograph individually, with any sibling who also attends Lilliput and in a class photo.

Then in 3 weeks from picture day all children receive a portrait package with their photos from school. Parents can preview portraits in the comfort of their own home. Parents can pay online for the portrait they want to keep and have the option to order more portraits and other photo products online.
